3. Treasurer's Report:

3.1 Current Balance- \$2525.19

4. Updates for Annual Conference, April 23-24, 2010: Ben will serve as the conference chair

4.1 Oregon Middle Level Association: Debbie reported that OMLE is not prepared to partner with us this year for a regional conference but may be interested next year. Jan Burgess will continue to be our liaison with the Oregon folks.

4.2 Location Updates: Ben and Keith both contacted Green River Community College and they are willing to partner with us for the Friday portion of the conference. Ben is still waiting for confirmation and cost. Rainier M.S. is a viable option for the Saturday portion of the conference if GRCC is unable to accommodate us.

4.3 Status of keynote speakers: Rick Wormeli is penciled in for the morning portion of Friday and Christian Moore is confirmed for the afternoon. Jack Berckmeyer is confirmed for Saturday's keynote.

4.4 Anticipated Conference Expenses:

4.4.1 Presenters- Rick has requested that Rick Wormeli donate his time on Friday morning, if he is unable to do so the cost will be \$2,000 for half the day or \$4,000 for the full day. Possible reimbursement of travel expenses for Christian Moore and Jack Berckmeyer

4.4.2 Venue- Dependent on location

4.4.3 Meals- Dependent on location, if at Rainier MS we can use the district for catering

4.4.4 Liability Insurance (if needed)- to be obtained as soon as venue is confirmed

4.4.5 Postcards- Dependent on quantity needed, quality of materials and postage

4.5 Publicity:

4.5.1 Website- Dotty will continue to update conference information as it becomes available

4.5.2 OSPI- Dotty will update information on the OSPI site as it becomes available

4.5.3 NMSA- Debbie or Keith will get the conference listed on NMSA site as soon as venues and keynote speakers are confirmed
